- EN ISO 11925-2:2020 Reaction to fire tests-Ignitability of building products subjected to direct impingement of flame-Part 2: Single-flame source test.

#### Mounting and fixing (For EN 13823:2010+A1:2014):

There is no ventilation cavity behind the specimen.

Test sample is installed on the substrate by screw (test substrates is calcium silicate board meets the requirement of EN13501-1 of Class A2-s1,d0, the density of 900 kg/m<sup>3</sup> and thickness of 10mm).

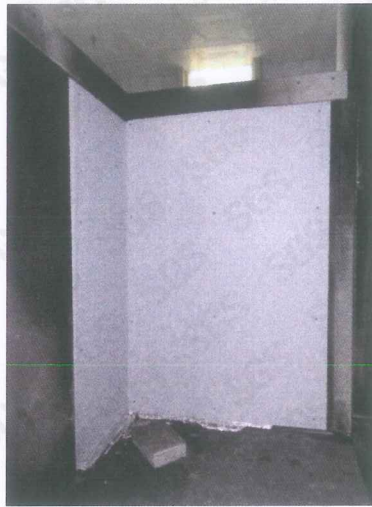

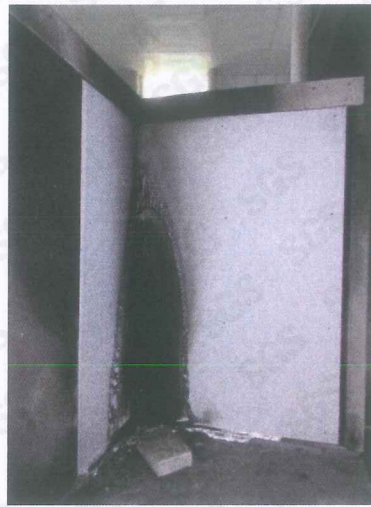
